7. **LIABILITY FOR KITTEN UPON TRANSFER.** AT THE MOMENT, THE KITTEN IS IN THE PHYSICAL POSSESSION OF THE PURCHASER BY VIRTUE OF HAVING BEEN PLACED IN A TRAVELING CRATE WITH THE DOOR FASTENED ("TRANSFER"), ALL LIABILITY AND RESPONSIBILITY CONCERNING THE KITTEN IRREVOCABLY PASSES FROM THE SELLER TO THE PURCHASER, INCLUDING BUT NOT LIMITED TO PHYSICAL CONDITION AND HEALTH. THE PURCHASER EXPRESSLY ACKNOWLEDGES AND AGREES THAT THE PURCHASER HAS BEEN GIVEN THE OPPORTUNITY, PRIOR TO ENTERING THIS CONTRACT, TO HAVE THE KITTEN'S PHYSICAL CONDITION AND HEALTH ASSESSED BY A VETERINARIAN OF THE PURCHASER'S CHOICE AND TO THE PURCHASER'S COMPLETE SATISFACTION. PURCHASER ALSO EXPRESSLY ACKNOWLEDGES AND AGREES THAT THIS PROVISION OF THIS CONTRACT IS REASONABLE AND NECESSARY TO PROTECT THE SELLER FROM ANY AND ALL POST-SALE ISSUES. ***NOTWITHSTANDING ANYTHING TO THE CONTRARY CONTAINED IN THIS AGREEMENT, THE SELLER, AS A PART OF THIS AGREEMENT, HEREBY PROVIDES THE FOLLOWING INSURANCE TO THE PURCHASER CONCERNING THIS TRANSACTION: FOR A PERIOD OF 30 (THIRTY) DAYS AFTER TRANSFER ("INSURANCE PERIOD"), THE KITTEN WILL BE COVERED BY TRUPANION INSURANCE (SEE POLICY FOR EXACT COVERAGE). IF THE PROBLEM IS A GENETIC DEFECT, IT MUST BE DISCOVERED, DIAGNOSED, AND DOCUMENTED DURING THE INSURANCE PERIOD BY THE VETERINARIAN OF THE PURCHASER'S CHOICE, WHICH ALLEGED GENETIC DEFECT IS SUBJECT TO VERIFICATION BY A VETERINARIAN SELECTED BY THE SELLER AND/OR BY TRUPANION AND AT THE SELLER'S AND/OR TRUPANION'S EXPENSE. IF IT IS DETERMINED THAT THE KITTEN HAS A GENETIC DEFECT, THE SELLER PROMPTLY WILL TAKE BACK THE KITTEN (AT THE SELLER'S REASONABLE TRANSPORTATION EXPENSE) AND REPLACE IT WITH ANOTHER KITTEN THAT MEETS CONVENTIONAL STANDARDS. THE SELLER HAS PAID THE INSURANCE PREMIUM ON BEHALF OF THE PURCHASER. IN THE EVENT OF A CLAIM, THE PURCHASER WILL BE LIABLE FOR A TEN PERCENT (10%) DEDUCTIBLE. A COPY OF THE APPLICABLE TRUPANION INSURANCE POLICY IS ATTACHED TO THIS AGREEMENT AND HEREBY MADE A PART OF THIS AGREEMENT FOR ALL RELEVANT PURPOSES.*** **INITIALS** _____

ALTERING AGREEMENT

PURCHASER MUST AGREE TO SPAY/NEUTER THE KITTEN DESCRIBED IN THIS CONTRACT ACCORDING TO THE FOLLOWING REQUIREMENTS:

1. PURCHASER AGREES TO ALTER THIS KITTEN WITHIN THE TIME FRAME STIPULATED — MALES & FEMALES: 6 MONTHS OLD. DATE FOR THIS KITTEN TO BE SPAYED/ALTERED: _____
2. PURCHASER WILL PROVIDE SELLER WITH PROOF OF ALTERING IN THE FORM OF A DATED RECEIPT FROM A CERTIFIED VETERINARIAN THAT INCLUDES A DESCRIPTION OF THE ANIMAL INVOLVED. WHEN SELLER RECEIVES SUCH COPY, SELLER WILL GIVE BUYER THE CFA BLUE SLIP TO REGISTER KITTEN WITH CFA. KITTEN IS NOT A TRUE PEDIGREED KITTEN UNLESS BUYER SENDS THIS BLUE SLIP WITH FEE TO CFA. IF NOT REGISTERED, CURL NUMBERS DROP. SO PLEASE REGISTER YOUR CURL!!
3. IF NO PROOF OF ALTERING IS RECEIVED, THE PURCHASER WILL AGREE TO PAY THE SELLER \$100 PER MONTH EACH MONTH NOT NEUTERED OR SPAYED AFTER 6 MONTHS OLD. THIS IS TO INSURE THE HEALTH AND INTEGRITY OF OUR BREED. **THIS WILL BE STRICTLY ENFORCED.**
4. SHOULD THERE BE A MEDICAL REASON AS TO WHY THIS KITTEN SHOULD NOT BE ALTERED, THE PURCHASER SHOULD CONTACT THE SELLER WITH A WRITTEN STATEMENT FROM A VETERINARIAN STATING THE REASON. THE SELLER WILL NOT BE RESPONSIBLE FOR ANY VETERINARIAN EXPENSES.
5. **IF BRED** INTENTIONALLY OR UNINTENTIONALLY, SELLER MAY RECLAIM THIS MALE/FEMALE CAT AND ALL OF ITS OFFSPRING WITHOUT REMUNERATION. TRAVEL AND MEDICAL EXPENSES ARE BUYERS RESPONSIBILITY. BUYER MUST PAY DIFFERENCE OF PET STATUS TO BREEDER STATUS TO PROCURL HAREM.
